The primary purpose of the said corporation is to purchase, invest, hold, acquire, take over and manage all or any part of the rights, assets, business and real or personal property of any person, firm, association, partnership, syndicate, or corporation, including stocks, bonds and other securities of any other corporations, association, firm or entity, domestic or foreign, carrying on any business which the corporation is authorized to carry on or possessed of property, cash, checks, bonds, stock, debentures, contracts, or obligations, to receive, collect, and dispose of the interest, dividends, and income arising from such property; and to possess and exercise in respect thereof all the rights, powers, and privileges of ownership, including all voting powers of any stock so owned, without acting as stockbroker or dealer in securities, nor engage in investment solicitation nor investment taking activity from public investors.
